## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of February 12, 2024, by Brookside Mezzanine Fund IV, L.P., a Delaware limited partnership (“Assignee”), in favor of WasteXpress Environmental LLC, a Delaware limited liability company (“Assignor”).

### **WITNESSETH:**

WHEREAS, pursuant to that certain Security and Pledge Agreement dated January 25, 2023, by and among Assignee, Assignor, and the other parties thereto (the “Security Agreement”), recorded on January 25, 2023, at Reel No. 7952, Frame 0265, United States Patent and Trademark Office, Assignor granted a security interest in a certain trademark in favor of Assignee to secure certain debt owing from Assignor to Assignee;

**WHEREAS**, Assignor has paid all outstanding amounts currently owing under that certain Note Purchase Agreement, dated as of January 25, 2023, by and between Assignor and Assignee and the other financing documents executed in connection therewith;

WHEREAS, Assignor has requested that Assignee (i) terminate and release the liens and interests of Assignee in Assignor’s trademark as set forth in **Exhibit A** attached hereto (the “Trademark”), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office (“USPTO”) and other appropriate offices; and

WHEREAS, Assignee has agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

- (1) Assignee hereby (i) releases and terminates its security interests in the Trademark and (ii) reassigns to Assignor all right, title and interest of Assignee in and to the Trademark.
- (2) Assignee understands and agrees that this Release may be recorded by or for the Assignor with the USPTO.
