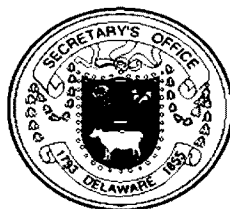

C. 1953, § 242 (the “*Act*”).

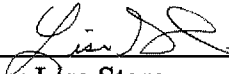
1. Name. The name of the corporation is DrChrono Inc.
2. Amendment to the Certificate of Incorporation. The Certificate of Incorporation of the Company is hereby amended by deleting ARTICLE I thereof in its entirety and inserting the following in lieu thereof:
