**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of December 22, 2023, is made by **CITIZENS BANK, N.A.** (the “Agent”), in favor of **ASPIRE BAKERIES LLC** (f/k/a ARYZTA LLC), a Delaware limited liability company (the “Company”).

**WHEREAS**, pursuant to the terms and conditions of (i) that certain U.S. Second Lien Pledge and Security Agreement, dated as of May 3, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”; capitalized terms used and not otherwise defined herein have the meanings specified in the Security Agreement), by and among the Company, as a Grantor, the other Grantors party thereto and the Agent, as administrative agent and collateral agent for the Secured Parties, (ii) that certain U.S. Second Lien Intellectual Property Security Agreement, dated as of May 3, 2021 (the “Original IPSA”), by and between the Company and the Agent, and (iii) that certain Supplement to U.S. Second Lien Intellectual Property Security Agreement, dated as of August 2, 2021 (the “IPSA Supplement”), by and between the Company and the Agent, the Company granted to the Agent for the ratable benefit of the Secured Parties a continuing security interest in and continuing lien upon, and right of set off against, any and all right, title and interest of the Company in and to the Intellectual Property Collateral shown on Schedule I attached hereto (collectively, the “Released IP”);

**WHEREAS**, the Original IPSA was recorded with (i) the United States Patent and Trademark Office on May 3, 2021, at (A) Reel 056110, Frame 0885 and (B) Reel 7277, Frame 0455, and (ii) the Canadian Intellectual Property Office;

**WHEREAS**, the IPSA Supplement was recorded with (i) the United States Patent and Trademark Office on October 21, 2021, at (A) Reel 057867, Frame 0644 and (B) Reel 7467, Frame 0788, and (ii) the Canadian Intellectual Property Office;

**WHEREAS**, that certain Partial Release of Security Interest in Trademarks, dated as of March 22, 2022, by and between the Agent and the Company, was recorded with the United States Patent and Trademark Office on March 22, 2022, at Reel 7668, Frame 0163 and released two Trademarks from the Intellectual Property Collateral; and

**WHEREAS**, the Company has requested, and the Agent wishes to provide, a document suitable for recording in the United States Patent and Trademark Office and the Canadian Intellectual Property Office for purposes of recording the release, relinquishment, and discharge of the Agent’s security interest in the Released IP.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases, without any

representation, recourse or undertaking by the Company, any and all liens on and security interests in the Released IP.
