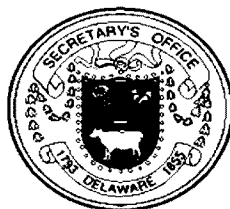

THIRD: The corporation surviving the merger is RevSpring, Inc., a Delaware corporation (the "Surviving Corporation").

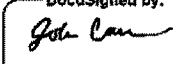
FOURTH: The Certificate of Incorporation of RevSpring, Inc. shall be the Certificate of Incorporation of the Surviving Corporation.
