RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 14, 2024, is made by TRIMONT LLC (formerly, TRIMONT REAL ESTATE ADVISORS, LLC) as collateral agent (in such capacity, together with its successors and assigns in such capacity, the “Agent”), in favor of FILENE’S BASEMENT, LLC (the “Grantor”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 19, 2019 (the “Trademark Security Agreement”), made by the Grantor in favor of the Agent, the Grantor granted a lien on and security interest to the Agent (the “Security Interest”) in certain trademarks more fully described therein (the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 8, 2023, at Reel/Frame 8159/0241; and

WHEREAS, the Agent now desires to terminate and release its Security Interest in the Trademarks, including the Trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges any and all Security Interest in (a) the Trademarks, including the registrations and applications for registration referred to on Schedule 1 here; (b) all extensions or renewals of any of the foregoing; (c) all of the goodwill of the business connected with the use of, and symbolized by the foregoing; (d) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and (e) all Proceeds of the foregoing, including any licenses, royalties, income, payments, claims, damages and proceeds of suit. The Agent, on behalf of the Lenders, hereby grants, assigns, transfers and conveys to the Grantor, effective as of the date of this Release, the entire right, title and interest in and to the Trademarks, including the Trademarks listed on Schedule 1 hereto.


3. Recordation. The Agent authorizes the Grantor and its designees to record this Release with the United States Patent and Trademark Office or any other applicable governmental. The Agent agrees to take all further actions, and provide to the Grantor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
