**IP SUPPLEMENT**

This IP SUPPLEMENT, dated as of February 5, 2024, is delivered pursuant to and supplements (i) the Amended and Restated Security Agreement dated as of May 5, 2023 (as amended, modified, restated, or supplemented from time to time, the “*Security Agreement*”), among GENSTAR SCF MERGER SUB LLC, a Delaware limited liability company, SONNY’S ENTERPRISES, LLC, a Delaware limited liability company, SONNY’S HOLDINGS, LLC, a Delaware limited liability company, the other Debtors (as defined therein) party thereto from time to time, and BLUE OWL CAPITAL CORPORATION (formerly known as Owl Rock Capital Corporation), as Administrative Agent, and (ii) the Trademark Security Agreement, dated as of May 5, 2023 (the “*IP Security Agreement*”), by Debtor in favor of the Administrative Agent. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the IP Security Agreement.

Debtor hereby confirms its grant to the Administrative Agent of a Lien on and security interest in all of Debtor’s right, title and interest in the Collateral (as defined in the Security Agreement), including the Trademark Collateral (in each case, as supplemented hereby). Schedule B to the Security Agreement and Schedule 1 to the IP Security Agreement are each hereby amended to include reference to all trademark(s) set forth on Schedule A annexed hereto, which, for the avoidance of doubt, shall hereafter constitute part of Schedule B to the Security Agreement and Schedule 1 to the IP Security Agreement.

THIS IP SUPPLEMENT SHALL BE CONSTRUED AND DETERMINED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF NEW YORK.
