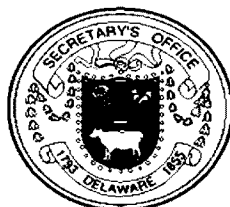

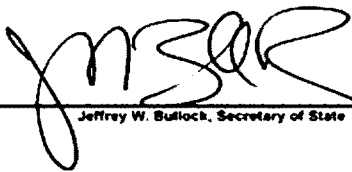

STATE OF DELAWARE CERTIFICATE OF MERGER

Pursuant to Section 264(c) of the Delaware General Corporation Law and Section 18-209 of the Delaware Limited Liability Company Act, the undersigned corporation delivers this Certificate of Merger:

1. The names and jurisdictions of formation of the merging entities are MTS III Vital Decisions Blocker Corp., a Delaware corporation, and Vital Decisions Acquisition LLC, a Delaware limited liability company (collectively, the “Merging Entities”).
