**TERMINATION AND RELEASE
OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of February 13th, 2024 by Pacific Premier Bank, a California commercial bank and successor in interest to Opus Bank (the “Secured Party”).

WHEREAS, Katzkin Leather, Inc., a Delaware corporation (the “Grantor”) and the Secured Party entered into a Trademark Security Agreement, dated as of June 21, 2016 (the “Security Agreement”) which Security Agreement was recorded with the United States Patent and Trademark Office on June 22, 2016, at Reel 005818, Frame 0718 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Trademark Collateral (as defined in the Security Agreement), including, without limitation, the trademarks listed on Exhibit A hereto. The Trademark Collateral and the Trademarks are referred to herein collectively as the “Intellectual Property”; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party’s right, title and interest in and to such Intellectual Property, effective as of the date set forth above.

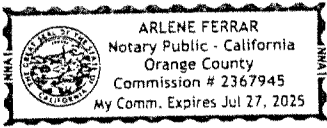
