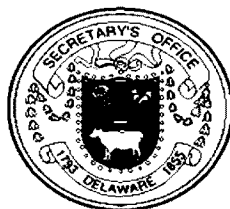

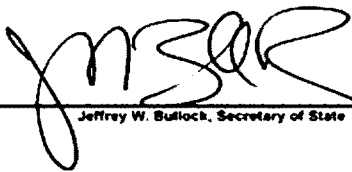

STATE OF DELAWARE CERTIFICATE OF MERGER

Pursuant to Section 252 of the Delaware General Corporation Law:

1. The names and jurisdictions of incorporation of the merging entities are Endzone Merger Sub, Inc., a Delaware corporation, and Evolent Specialty Services, Inc., a California corporation (collectively, the "Merging Entities").

3. Evolent Specialty Services, Inc. will continue as the corporation surviving the merger and the name of the corporation surviving the merger shall continue to be Evolent Specialty Services, Inc.
4. The certificate of incorporation of the corporation surviving the merger shall be its certificate of incorporation.

6. A copy of the Merger Agreement will be furnished by Evolent Specialty Services, Inc., on request and without cost, to any stockholder of either Merging Entities.

Evolent Specialty Services, Inc. agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of either Merging Entity, and irrevocably appoints the Secretary of State as its agent to accept service of process in any such action, suit or proceeding and the address to which a copy of such process shall be mailed to it by the Secretary of State is 915 W. 8. The merger shall be effective as of January 31, 2024 at 11:59 p.m. Eastern Time.
