RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 15, 2024 (the “Effective Date”), is made by Wilmington Trust, Nation Association, as collateral agent (the “Collateral Agent”), in favor of DEPOSIT CHOICE, LLC, a Illinois limited liability company, CATALYTIC RISK MANAGERS & INSURANCE AGENCY, LLC, a California limited liability company, NATIONSBUILDERS INSURANCE SERVICES, INC., a Delaware corporation, ALIGN GENERAL INSURANCE AGENCY, LLC, a California limited liability company, NBIS CONSTRUCTION & TRANSPORT INSURANCE SERVICES, INC., a California corporation, and TIGERRISK PARTNERS LLC, a Delaware limited liability company (each a “Grantor” and collectively the “Grantors”).

WHEREAS, pursuant to that certain Second Lien U.S. Collateral Agreement, dated as of October 1, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among the Grantors, the other grantors from time to time party thereto and the Collateral Agent, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, the Grantors executed and delivered (i) a Trademark Security Agreement, dated as of December 1, 2021 and (ii) a Trademark Security Agreement, dated as of April 21, 2023 (each a “Trademark Security Agreement” and collectively the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on (i) December 3, 2021 at Reel/Frame 7516/0949 and (ii) April 28, 2023 at Reel/Frame 8054/0881, respectively;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates, and cancels all of its security interest in and to the Trademark Collateral, including but not limited to the trademarks set forth in Schedule I attached hereto, arising under the Collateral Agreement and the Trademark Security Agreements. If and to the extent that the Collateral Agent has acquired any right, title, or interest in and to the Trademark Collateral under the Trademark Security Agreements or the Collateral Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys, and re-assigns such right, title or interest to the Grantors. The Collateral Agent authorizes and requests that this Release be recorded at the United States Patent and Trademark Office.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels each Trademark Security Agreement.


4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantors all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with and governed exclusively by the laws of the State of New York, without regard to conflicts of law or choice of law principles.
