

WHEREAS, pursuant to (a) that certain First Lien Credit Agreement, dated as of March 10, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Credit Agreement"), among FRANCHISE GROUP, INC., a Delaware corporation ("Lead Borrower"), VALOR ACQUISITION, LLC, a Delaware limited liability company ("Valor"), FRANCHISE GROUP NEWCO INTERMEDIATE AF, LLC, a Delaware limited liability company ("NewCo AF"), FRANCHISE GROUP NEWCO PSP, LLC, a Delaware limited liability company ("Newco PSP", and together with Lead Borrower, Valor and NewCo AF, individually and collectively, the "Borrowers"), the Lenders (as defined in the First Lien Credit Agreement) from time to time party thereto, JPMORGAN CHASE BANK, N.A., as the administrative agent, and the Collateral Agent, and (b) that certain First Lien Collateral Agreement, dated as of March 10, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Collateral Agreement") among the Borrowers, the other grantors from time to time party thereto and the Collateral Agent, each Grantor, as an Affiliate of Lead Borrower, granted to the Collateral Agent, in its capacity as collateral agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the First Lien Collateral Agreement, each Grantor executed and delivered to the Collateral Agent a First Lien Trademark Security Agreement, dated as of November 22, 2021 (the "First Lien Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to (a) that certain First Lien Credit Agreement, dated as of November 22, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Badcock Credit Agreement"), among the Borrowers, the Lenders (as defined in the Badcock Credit Agreement) from time to time party thereto, JPMORGAN CHASE BANK, N.A., as the administrative agent, and the Collateral Agent, and (b) that certain First Lien Collateral Agreement, dated as of November 22, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Badcock Collateral Agreement" and together with the First Lien Collateral Agreement, each, a "Collateral Agreement"), among the Borrowers, the other grantors from time to time party thereto and the Collateral Agent, each Grantor granted to Collateral Agent, in its capacity as collateral agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Badcock Collateral Agreement, each Grantor executed and delivered to the Collateral Agent a First Lien Trademark Security Agreement, dated as of November 22, 2021 (the "Badcock Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office:

WHEREAS, pursuant to that certain Third Amended and Restated Loan and Security Agreement, dated as of March 10, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among the Borrowers, certain Subsidiaries (as defined in the Loan Agreement) of each of the Borrowers, the other Loan Parties (as defined in the Loan

Agreement) from time to time party thereto, the Lenders (as defined in the Loan Agreement) from time to time party thereto and the Collateral Agent, each Grantor granted to the Collateral Agent, in its capacity as agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Loan Agreement, each Grantor executed and delivered to the Collateral Agent a Trademark Security Agreement, dated as of November 22, 2021 (the "ABL Trademark Security Agreement"), and together with the First Lien Trademark Security Agreement and the Badcock Trademark Security Agreement, each, a "Trademark Security Agreement") for recordal with the United States Patent and Trademark Office; and

WHEREAS, (a) the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 22, 2021 at Reels/Frames 007501/0967 and 007502/0006 and on November 22, 2021 at Reel/Frame 007519/0293, (b) the Badcock Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 23, 2021 at Reels/Frames 007503/0676, 007503/0739, and 007503/0600, and (c) the ABL Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 22, 2021 at Reels/Frames 007502/0050, 007502/0061, and 007502/0077.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the First Lien Credit Agreement, the Badcock Credit Agreement, the applicable Collateral Agreement, the Loan Agreement, or the applicable Trademark Security Agreement, as applicable.
- 2. <u>Release</u>. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels, in its entirety, for the benefit of each Grantor, and its successors and assigns, all of Collateral Agent's security interest in and to all of its right, title and interest in, to and under all of the following Collateral of each such Grantor (collectively, the "<u>Trademark Collateral</u>"):
- (a) the United States Trademark registrations and Trademark applications listed on <u>Schedule</u> A attached hereto,
- (b) all of the goodwill of such Grantor's business connected with the use of and symbolized by such Trademarks,
- (c) all rights to sue or otherwise recover for any past, present and future infringement, dilution, or other violation thereof,
- (d) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, proceeds of suit and other payments now or hereafter due and/or payable with respect thereto, and
 - (e) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.
- 3. <u>Termination</u>. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels each Trademark Security Agreement.
- 4. <u>Further Assurances</u>. The Collateral Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance

(including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

- 5. <u>Recordation</u>. The Collateral Agent authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release.
- 6. <u>Execution in Counterparts</u>. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
- 7. Governing Law. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION, EXCEPT TO THE EXTENT THAT THE UCC PROVIDES THAT PERFECTION OF THE SECURITY INTEREST HEREUNDER, OR REMEDIES HEREUNDER, IN RESPECT OF ANY PARTICULAR COLLATERAL ARE GOVERNED BY THE LAWS OF A JURISDICTION OTHER THAN THE STATE OF NEW YORK, IN WHICH CASE THE LAWS OF SUCH JURISDICTION SHALL GOVERN WITH RESPECT TO THE PERFECTION OF THE SECURITY INTEREST IN, OR THE REMEDIES WITH RESPECT TO, SUCH PARTICULAR COLLATERAL.
