## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and entered by and between Warner Hal-Hen, LLC ("Assignor") and Warner Tech-Care Products, LLC ("Assignee") (collectively referred to as the "Parties").

WHEREAS, as part of dissolving and winding up its business, Assignor wishes to assign its rights in the Mark to Assignee.

Assignor hereby assigns, sells and transfers to Assignee all of its rights, title and interest in and to the Marks, including (i) all registration rights with respect to the Marks, (ii) all goodwill associated with the Marks, and (iii) all income, royalties or claims relating to the Mark due or payable on or after the date of this Assignment.

Assignor represents and warrants (i) that Assignor is the exclusive owner of the Marks, (ii) that Assignor possesses all rights, title and interest in and to the Marks, (iii) that Assignor has the power to enter into this Assignment, and (iv) that the rights transferred in this Assignment are free of any lien, encumbrance or adverse claim.

Assignor agrees that Assignee may seek and maintain registration of the Marks, with any registered trademark rights to be owned by Assignee. Assignor agrees to assist Assignee, upon request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of this Assignment.

The covenants and conditions contained in this Assignment shall apply to and bind the Parties and their heirs, legal representatives, successors and permitted assigns.
