INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “Assignment”), is made and entered into as of the 6th day of October 2022, by and between Constellation Brands, Inc., a Delaware corporation (“Seller”), each of Seller’s direct or indirect subsidiaries set forth on the signature page hereto (each an “Assignor”, collectively with Seller, the “Assignors”), on the one hand and The Wine Group LLC, a Delaware limited liability company (“Assignee”), on the other hand.

WHEREAS, pursuant to that certain Asset Purchase and Sale Agreement between Assignee and Seller, dated as of October 6, 2022 (the “Purchase Agreement”), the Seller Parties are concurrently herewith selling, assigning, conveying, transferring and delivering to Assignee the Purchased Assets (as that term is defined in Article 1, Section 1.1 of the Purchase Agreement).

WHEREAS, Assignors own certain Exclusive Intellectual Property (as that term is defined in Article 1, Section 1.1 of the Purchase Agreement), including, but not limited to, the items set forth on Schedule A (attached hereto and incorporated herein by reference); and

WHEREAS, Assignors have agreed to assign to Assignee all of the rights, title, and interests of Assignors in and to the Exclusive Intellectual Property, and Assignee has agreed to accept said assignment.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

1. **Defined Terms.** All capitalized terms used and not otherwise defined in this Assignment (including the Schedule attached hereto) shall have the same meanings as set forth in the Purchase Agreement.

2. **Assignment.** For the good and valuable consideration recited in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby irrevocably sell, assign, transfer, and convey to Assignee, its successors and assigns, and Assignee, as the successor to the portion of the ongoing and existing business to which the Exclusive Intellectual Property pertain, hereby accepts from Assignors, all of the worldwide rights, title, and interests of Assignors in and to the Exclusive Intellectual Property, together with the goodwill of the business symbolized by the Exclusive Intellectual Property, with the right to recover for damages and profits and all other remedies for past infringements thereof, including without limitation, the following:

(a) The Exclusive Intellectual Property and, to the extent applicable, all issuances, pending applications, extensions, and renewals thereof;

(b) All rights of any kind whatsoever accruing under or relating to the Exclusive Intellectual Property provided by applicable law, by international treaties, and conventions and otherwise, including common law rights; and

(c) Any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to the Exclusive Intellectual Property.

3. Further Assurances. Assignors agree to, at Assignee's expense, perform any further acts and to execute and provide to Assignee any and all other documents that may be necessary to effect the assignment of the Exclusive Intellectual Property to Assignee after Assignee's request therefor and to assist Assignee in any manner reasonably necessary and requested by Assignee in connection with the assignment, prosecution, enforcement and maintenance of the Exclusive Intellectual Property.

4. Purchase Agreement Controls. Assignee acknowledges that the Seller Parties hereto make no representation or warranty with respect to the Exclusive Intellectual Property being conveyed hereby except for those representations and warranties of Seller specifically set forth in the Purchase Agreement. The terms and conditions of the Purchase Agreement are incorporated herein by reference. In the event of a conflict or inconsistency between the provisions of this Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement will prevail.

5. General Provisions. Except as to matters controlled or pre-empted by federal law, any and all claims or controversies of any kind (whether at law, in equity, in contract, in tort, or otherwise) arising out of or relating to the parties' rights and responsibilities under this Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to its principles of conflicts of laws, including without limitation Delaware's laws relating to applicable statute of limitations and burdens of proof and available remedies. This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by electronic transmission shall be as effective as delivery of a manually executed counterpart of this Assignment.




