2. **Representation and Warranty.** Assignor warrants and represents to Assignee that Assignor has full and unencumbered legal and equitable title to the Marks and has not granted any rights in the Marks to any other person, firm, corporation or entity.

3. **Consideration.** As consideration for the assignment of the Assets and for this agreement, and as a condition of the transfer of the Assets hereunder, Assignee will pay to Assignor the amount of one dollar (\$1.00).
