RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”), dated as of February 16, 2024, is made by U.S. BANK NATIONAL ASSOCIATION, as collateral agent (as successor in interest to Credit Suisse AG, Cayman Islands Branch and together with its successors and assigns in such capacity, the “Collateral Agent”) for the benefit of the Secured Parties (as defined in the Collateral Agreement (as defined below)), in favor of NEW CENTAUR, LLC, a Delaware limited liability company, CENTAUR ACQUISITION, LLC, an Indiana limited liability company, and HOOSIER PARK, LLC, an Indiana limited liability company (collectively, the “Pledgors” and each, a “Pledgor”).

WITNESSETH

WHEREAS, the Pledgors, each other pledgor identified in the Collateral Agreement and the Collateral Agent entered into that certain Collateral Agreement, dated as of December 22, 2017 (as supplemented by that certain Supplement No. 1, dated as of July 16, 2018 and that certain Supplement No. 2, dated as of July 20, 2020 and as it may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Pledgors executed and delivered to the Collateral Agent that certain Trademark Security Agreement, dated as of July 16, 2018 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on July 17, 2018 at Reel/Frame No. 6383/0345, pursuant to which each Pledgor granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of such Pledgor’s right, title and interest in or to any and all of the IP Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, the Pledgors have requested that the Collateral Agent, and the Collateral Agent has agreed to, release its security interest in all right, title and interest in or to the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to the IP Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the IP Collateral under the Collateral Agreement and the Trademark Security Agreement, and authorizes and requests that this Release be recorded with the USPTO at the Pledgors’ sole cost and expense.

This Release may be executed and delivered by facsimile or other means of electronic transmission and such transmission shall constitute an original for all purposes.


This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be construed in accordance with and governed by the law of the state of New York, without reference to its conflict of laws principles.

U.S. BANK NATIONAL ASSOCIATION is executing this Release solely in its capacity as successor Collateral Agent under the Collateral Agreement, and in acting hereunder, shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Collateral Agent in the Collateral Agreement as if such rights, privileges, immunities and indemnities were set forth herein.



