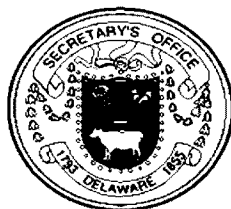

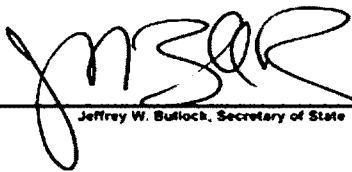

9. This Certificate of Merger and the Merger shall become effective upon the filing of such Certificate of Merger with the Secretary of State of the State of Delaware.

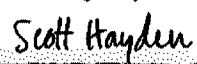
