**SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Supplement No. 1 to Intellectual Property Security Agreement (this "Supplement") is made as of February 14, 2024, by and between (i) FIRST-CITIZENS BANK & TRUST COMPANY (the "Bank") and (ii) MAD STREET DEN INC., a Delaware corporation (the "Grantor").

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of August 29, 2022 (as amended and of record from time to time hereinafter, the "Agreement") in favor of the Bank, pursuant to which the Grantor granted a security interest in certain Intellectual Property Collateral. Capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement;

WHEREAS, the Agreement was recorded on 09/07/2022 at Reel 061008/ Frame 0164 with the patent division of the U.S. Patent and Trademark Office;

WHEREAS, the Agreement was recorded on 09/07/2022 at Reel 7841/ Frame 0613 with the trademark division of the U.S. Patent and Trademark Office; and

WHEREAS the Grantor desires to confirm the grant of a security interest in certain additional Intellectual Property Collateral in favor of the Bank.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
