DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT ("**Assignment**"), EFFECTIVE AS OF THE LAST DATE EXECUTED BELOW, IS MADE BY AND BETWEEN

BERCHTOLD CORPORATION (hereinafter "**ASSIGNOR**"), a corporation organized under the laws of Delaware with its principal place of business located at 1950 Hanahan Road Charleston, South Carolina, 29406 United States of America; and

STRYKER CORPORATION (hereinafter "**ASSIGNEE**"), a corporation organized under the laws of Michigan with its principal place of business located at 1941 Stryker Way, Portage, Michigan, 49002 United States of America.

WHEREAS:


- A **ASSIGNOR** is the sole owner in respect of United States trademark registration number 3295248 for the mark INSTADRIVE (hereinafter "**the MARK**");
- B **ASSIGNEE** is desirous of acquiring all of the worldwide right, title and interest in and to the **MARK**; and
- C **ASSIGNOR** and **ASSIGNEE** may have previously undertaken certain steps to effectuate the transfer of the **MARK** and this Assignment is intended to confirm **ASSIGNEE** as the owner and correct any incomplete or incorrect chains of title, to the extent such is necessary.

NOW, THEREFORE, for good and valuable consideration of the sum of one dollar (US \$1.00), receipt of which is hereby acknowledged, to the extent not already sold, assigned or transferred, **ASSIGNOR** does hereby sell, assign and transfer to **ASSIGNEE** all of its worldwide right, title and interest in the (i) the **MARK**; (ii) all legal equivalents of the **MARK** throughout the world; (iii) all common law rights and the goodwill of the business connected with the use of and symbolized by the **MARK**, in the United States and throughout the world and (iv) the right to sue and collect past damages in connection with the **MARK**, in the United States and throughout the world (i-iv collectively referred to as the "Trademark Rights"), and Assignee, as successor to Assignor's entire business or that portion of the business to which the Marks pertain, agreed to accept the Trademark Rights.

ASSIGNOR hereby declares that **ASSIGNEE** may take the steps to record this assignment in the sole name of **ASSIGNEE**. **ASSIGNOR** hereby undertakes that it shall, without further consideration, but at the expense of **ASSIGNEE**, execute all documents and do all such acts and things as **ASSIGNEE** may in its absolute discretion consider necessary or desirable to enable a Trademark Registration or any other form of protection to be issued in respect of any of said **MARK** in any part of the world and to enable or to assist **ASSIGNEE** to defend oppositions thereto, to maintain the **MARK** and to prosecute for the infringement thereof.

IN WITNESS WHEREOF, **ASSIGNOR** has caused these presents to be signed by its duly appointed trustee having full authority to convey its property and **ASSIGNEE** has caused these presents to be signed by its duly appointed trustee. 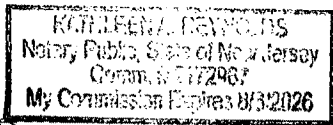
