**ASSIGNMENT OF SECURITY INTEREST IN

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Assignment"), dated as of February 14, 2024, is entered into by and between Credit Suisse (AG) Cayman Islands Branch ("Assignor") and Jefferies Finance LLC ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the IP Security Agreement referred to below, whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of May 1, 2007 (as amended, restated, supplemented or otherwise modified, refinanced or replaced from time to time, the "Guarantee and Collateral Agreement") by and among the Grantor, the Assignor and certain other parties, the Grantor executed and delivered that certain Intellectual Property Security Agreement, dated as of February 20, 2013 (the "IP Security Agreement");

WHEREAS, the IP Security Agreement was recorded with the Office of Trademarks of the United States Patent and Trademark Office ("USPTO") on April 25, 2013 at Reel/Frame 5014/0732, and was recorded in the United States Copyright Office ("USCO") on May 15, 2013 at Volume 3629, Doc. No. 523;

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the IP Security Agreement, the Grantor granted to the Assignor, for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in the Intellectual Property Collateral, including the registered trademarks and trademark applications listed on Schedule A, and the copyright registrations and applications of such Grantor listed on Schedule B;

WHEREAS, pursuant to a Resignation, Consent and Appointment Agreement, dated as of February 14, 2024 (the "Resignation, Consent and Appointment Agreement"), Assignor assigned to Assignee, and Assignee assumed, all of Assignor's rights and obligations under the Guarantee and Collateral Agreement and the IP Security Agreement and the Security Interest granted thereunder; and


WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the USPTO and USCO.


