**REAFFIRMATION OF AND SUPPLEMENT TO  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Reaffirmation of and Supplement to Intellectual Property Security Agreement (this "Supplement"), dated as of February 15, 2024, is intended to supplement that certain Intellectual Property Security Agreement dated as of May 25, 2022, made by ASSEMBLY SOFTWARE LLC, a Delaware limited liability company ("Grantor") in favor of TEXAS CAPITAL BANK ("Bank") (as amended, restated, supplemented or otherwise modified, the "Intellectual Property Security Agreement") and recorded with the with the United States Copyright Office with respect to the Copyrights listed on Schedule A attached thereto on May 27, 2022 at Volume 15007 Document Number 522 and with the United States Patent and Trademark Office with respect to the Trademarks listed on Schedule B attached thereto on May 26, 2022 at Reel 7735 Frame 0112.

RECITALS

Bank has agreed to make certain advances of money and to extend certain financial accommodations to Grantor pursuant to that certain Loan and Security Agreement, dated as of May 25, 2022 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Loan Agreement"). Capitalized terms used but not defined herein shall have the meaning ascribed thereto in the Loan Agreement. Pursuant to the terms of the Loan Agreement, Grantor has granted to Bank a security interest in its personal property.

NOW, THEREFORE, Grantor agrees as follows:

AGREEMENT

Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of Grantor to Bank under the Loan Agreement, hereby grants and pledges to Bank , for the benefit of Bank , a security interest in all of Grantor's right, title and interest in, to the Intellectual Property of Grantor, including, without limitation, the Intellectual Property listed on Schedule 1 of this Supplement, subject to the terms and conditions of the Intellectual Property Security Agreement and the Loan Agreement. The undersigned Grantor further agrees that this Supplement may be attached to the Intellectual Property Security Agreement, and that the Intellectual Property listed on Schedule 1 of this Supplement shall be and become a part of the Intellectual Property referred to in the Intellectual Property Security Agreement and shall secure all Obligations of Grantor to Bank on the terms and conditions of the Intellectual Property Security Agreement and the Loan Agreement.

Grantor hereby reaffirms, ratifies, and confirms the granting of Grantor's security interests and performance obligations under the Intellectual Property Security Agreement and further acknowledges that each reference to the "Loan Agreement" contained in the Intellectual Property Security Agreement shall be, and shall be deemed to be, a reference to the Loan Agreement as defined herein. This Supplement shall be deemed to be a Loan Document for all purposes under the Loan Agreement.


