TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 27, 2024 (“Release”), is made by KeyBank National Association, as Collateral Agent (“Collateral Agent”) in favor of AMCP Clean Acquisition Company, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of June 15, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor and the Collateral Agent, and others party thereto, and the Trademark Security Agreement dated as of June 15, 2018 by and among the Grantor and Collateral Agent (“Trademark Security Agreement”), Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent, its successors and permitted assigns, on behalf of and for the benefit of and the ratable benefit of the Secured Parties, a continuing security interest in all of its right, title and interest in, to and under all Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on June 20, 2018 at Reel 6359 Frame 0001.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, its successors and permitted assigns, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, its successors and permitted assigns, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in all of Grantor’s right, title and interest in, to and under all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule I attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
