MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY

Each of M. W. WHIDBEY LLC, a Washington limited liability company (“Whidbey”), and STE. MICHELLE WINE ESTATES LLC, a Washington limited liability company (together with Whidbey, each a “Debtor” and, collectively, the “Debtors”), each of whose address is 14111 NE 145th Street, Woodinville, WA 98072, hereby acknowledges that, pursuant to the Note (as defined below), has granted to SMWE Washington Parent LLC (“Secured Party”), whose address is 9 W. 57th Street, 31st Fl, New York, NY 10019, a security interest in and to all of such Debtor’s right, title and interest in and to: (a) the trademarks and trademark registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by such Debtor (the “Trademarks”), together with the goodwill and assets of the business; (b) the patents and patent applications which are identified on Exhibit B attached hereto and herein incorporated by this reference owned by such Debtor (the “Patents”); and (c) the copyright registrations which are identified on Exhibit C attached hereto and herein incorporated by this reference owned by such Debtor (the “Copyrights”) to which such Trademarks, Patents, and Copyrights are appurtenant and all actions for infringement concerning the foregoing.

The terms and conditions of the aforementioned security interest are contained in that certain Promissory Note, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Note”), by and between International Wine & Spirits LLC, a Delaware limited liability company (the “Borrower”) and the Secured Party as the lender (the “Lender”), as security for the obligations as set forth in the Note and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Note or otherwise.

The parties hereby agree that this Memorandum and Notice of Security Interest in Intellectual Property and all claims shall be governed by the law of the State of New York, without giving effect to any conflict of law principles except federal laws relating to national banks and Sections 15, 16 and 17 of the Note are hereby incorporated by reference. Debtor hereby authorizes the filing of this Memorandum and Notice of Security Interest in Intellectual Property with the United States Patent and Trademark Office and/or the United States Copyright Office, as applicable.


