## **RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARK RIGHTS**

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), dated as of February 21, 2024, is made by JPMORGAN CHASE BANK, N.A., in its capacity as Administrative Agent (in such capacity, the "Agent") for the several banks and other financial institutions (the "Lenders") parties to the Credit Agreement (as defined below), in favor of SPC RESOURCES, INC. (as successor in interest to SCA PACKAGING NORTH AMERICA, INC., the "Obligor"). Capitalized terms used but not defined herein have the meanings given to them in the Trademark Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of March 8, 2007, by and among Tegrant Holding Corp., Tegrant Corp., the Lenders, the Agent and certain other parties thereto (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Obligor executed and delivered in favor of the Agent that certain Grant of Second Lien Security Interest in Trademark Rights, dated as of March 8, 2007 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office ("USPTO") on May 15, 2007 at Reel/Frame 003542/0418, 003542/0419, 003542/0420, 003542/0421, 003542/0422, 003542/0423, 003542/0424, 003542/0425, 003542/0426, 003542/0427 and 003542/0428;

WHEREAS, pursuant to the Credit Agreement and the Trademark Security Agreement, the Obligor granted to the Agent, for the benefit of the Agent and the Lenders, a security interest (the "Security Interest") in all of the Obligor's right, title and interest in, to and under the Collateral, including, without limitation, the Trademarks listed on Schedule I hereto; and

WHEREAS, the Obligor has requested that the Agent terminate and release its Security Interest in the Collateral.


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates and cancels the Trademark Security Agreement, (ii) terminates, cancels, discharges and releases its Security Interest in the Collateral and (iii) re-assigns to the Obligor any right, title or interest it may have in or to the Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.

The Obligor, and any successor to the Obligor (including any person or entity hereafter holding any right, title or interest in and to the Collateral) is hereby authorized to record this Release with the USPTO.
