RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), dated as of February 21, 2024, is made by TTGA SBIC PIONEER FUND I, LP, a Delaware limited partnership (“Secured Party”), and is as follows:

WHEREAS, Secured Party and BRD MANAGEMENT LLC, a Pennsylvania limited liability company (“BRD”), are parties to that certain Trademark Security Agreement, dated as of July 18, 2022 (the “Agreement”), which was recorded with The United States Patent and Trademark Office on August 16, 2022 in its records at Reel 7824, Frame 0109. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Agreement;

WHEREAS, pursuant to the Agreement, BRD granted to Secured Party a continuing security interest in and to all of the Trademark Collateral, which includes the Trademarks set forth on Schedule I attached hereto and made a part hereof; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral, including each Trademark set forth on Schedule I attached hereto.

NOW, THEREFORE, Secured Party hereby releases and terminates its security interest in, liens on, and all other rights in, to and under the Trademark Collateral, including each Trademark set forth on Schedule I attached hereto.
