RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), dated as of February 21, 2024, is made by TTGA SBIC PIONEER FUND I, LP, a Delaware limited partnership (“Secured Party”), and is as follows:

WHEREAS, Secured Party and CANFAB MANAGEMENT LLC, a California limited liability company (“Canfab”), are parties to that certain Trademark Security Agreement, dated as of July 18, 2022 (the “Agreement”), which was recorded with The United States Patent and Trademark Office on August 16, 2022 in its records at Reel 7824, Frame 0127. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Agreement;

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral, including each Trademark set forth on Schedule I attached hereto.


