UNITED STATES TRADEMARK SECURITY AGREEMENT

This UNITED STATES TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of February 21, 2024 is made by VIBRATION MOUNTINGS & CONTROLS, INC., a New Jersey corporation with an address of 113 Main Street, Bloomingdale, New Jersey 07403, BRD MANAGEMENT LLC, a Pennsylvania limited liability company with an address of 112 Fairview Avenue, Wind Gap, Pennsylvania 18091, and CANFAB MANAGEMENT LLC, a California limited liability company with an address of 182 Granite Street, Suite 101, Corona, California 92879 (together with each of their successors and assigns, “**Grantors**”), in favor of MANUFACTURERS AND TRADERS TRUST COMPANY, a New York banking corporation with an address of One M&T Plaza, Buffalo, New York 14203 in its capacity as Administrative Agent (together with its successors and assigns, in such capacity, “**Administrative Agent**”).

WHEREAS, Grantors, the Administrative Agent and certain other parties thereto executed that certain Security Agreement dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), pursuant to which Grantors agreed to grant and granted in favor of the Administrative Agent a security interest in certain of their assets to secure obligations owing to the Administrative Agent and certain other Secured Parties (as defined in the Security Agreement).

WHEREAS, this Agreement has been executed by Grantors for the purpose of recording the grant of security interest herein and in the Security Agreement with the United States Patent and Trademark Office;

WHEREAS, Grantors own certain trademarks, including the applications and registrations thereof, and the trade name and common law rights thereto, together with the goodwill of the business connected with the use of and symbolized by the trademarks, including

that portion of the business to which the trademarks pertain, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the “**Trademarks**”);

NOW, THEREFORE, for good and valuable consideration, Grantors hereby pledge and grant to Administrative Agent (and confirm and ratify all other pledges and grants heretofore made to Administrative Agent) a security interest and lien in and to the Trademarks.






