Declaration of Correction

1. I am counsel of record for Hollywood Bed & Spring Manufacturing Co., Inc. This declaration is based on my personal knowledge.

2. As part of my representation of my client, I noticed that the record owner of INST-A-MATIC is listed as Linwood Hospitality LLC rather than Hollywood Bed & Spring Manufacturing Co., LLC. I investigated this discrepancy, including through discussions with my client and prior counsel of record for my client and by reviewing the relevant assignments.

3. This Declaration of Correction serves to correct the chain of title in the INST-A-MATIC mark, Registration No. 892024.

4. Hollywood Bed & Spring Mfg. Co, LLC (“Hollywood Bed LLC”) is a wholly owned subsidiary of Hollywood Bed & Spring Manufacturing Co, Inc. (“Hollywood Bed, Inc.”).

5. On June 30, 2020, Hollywood Bed, Inc. acquired Linwood Hospitality, LLC (“Linwood”) from Leggett & Platt, Inc. (“Leggett & Platt”).

6. Prior to that acquisition, on June 29, 2020, Leggett & Platt entered into an Asset Contribution Agreement with Linwood. Pursuant to this agreement, Leggett & Platt transferred certain assets, including the INST-A-MATIC mark, to Linwood.

7. After both the Asset Contribution Agreement referenced in paragraph 6, and the subsequent Linwood acquisition referenced in paragraph 5, it was realized that Leggett & Platt never owned the INST-A-MATIC mark as it represented was the case in the Asset Contribution Agreement. Rather, a wholly owned subsidiary of Leggett & Platt, L&P Property Management Co., owned the INST-A-MATIC mark. To clean up the transfer of the INST-A-MATIC mark by Leggett & Platt, L&P Property Management Co. entered into an assignment agreement with Leggett & Platt in which the INST-A-MATIC mark was transferred from L&P Property Management Co. to Leggett & Platt. This assignment was executed on October 23, 2020, and recorded on December 22, 2020, at Reel/Frame 7143/0520 (Assignment 7).

8. To ensure that the assignment from Leggett & Platt to Linwood was effective in light of the later-discovered information referenced in paragraph 7, Leggett & Platt and Linwood entered into *another* assignment agreement on December 11, 2020, that again assigned the INST-A-MATIC mark from the former to the latter. This assignment was recorded at

Reel/Frame 7160/0350 (Assignment 8). Although Assignment 8 was executed on December 11, 2020, it references the June 29, 2020 assignment, acknowledges that the assignment took place on June 29, 2020, and reflects the parties' intent for the assignment to have taken place on June 29, 2020 ("WHEREAS, pursuant to the Asset Contribution Agreement dated June 29, 2020, Assignor [Leggett & Platt] assigned all right, title, and interest in the Mark and the Registrations to the Assignee [Linwood] . . .").

9. Shortly afterwards, a corrective assignment was recorded on January 29, 2021, at Reel/Frame 7173/0350 (Assignment 9) correcting the assignee's entity type in Assignment 8 (Assignment 8 incorrectly characterized Linwood as a Delaware corporation rather than as a Delaware limited liability company).

10. Thus, at this point, the owner of the INST-A-MATIC mark was Linwood. However, on February 5, 2021, a change of name was recorded at Reel/Frame 7182/0009 (Assignment 6) changing the name of Linwood to Hollywood Bed & Spring Manufacturing Co., LLC. This change of name was executed on July 1, 2020, *after* the assignments discussed in paragraphs 5 and 6, but *before* it was realized that the chain of title had to be cleaned up via the assignments discussed in paragraphs 7, 8, and 9. Thus, although Assignment 6 should be the last in the chain, it appears before Assignments 7, 8, and 9 in the USPTO's database.

11. **Thus, the current owner of the INST-A-MATIC mark should be changed to Hollywood Bed & Spring Manufacturing Co., LLC to reflect the current owner of the mark. Registrant therefore requests that the USPTO records be updated to reflect that the current owner of the INST-A-MATIC mark and registration thereof is Hollywood Bed & Spring Manufacturing Co., LLC.**

The undersigned, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements may jeopardize the validity of the application or any resulting registration, declares that the facts set forth in this application are true; statements are made of his own knowledge are true; and all statements made on information and belief are believed to be true.
