
WHEREAS, Assignor has used and is the owner of the registered trademark "DRYBEV" together with common law rights therein (the "Trademark"); and

To the extent that a *nunc pro tunc* assignment is contrary to applicable law, then Assignor hereby unconditionally and irrevocably grants, assigns, and conveys to the Assignee all of the rights above as of the date set forth below.
