("JPM"), as successor Administrative Agent (in such capacity, the "Successor Administrative Agent"), and certain other parties thereto have entered into that certain Second Amended and Restated Credit Agreement and Agency Transfer (the "Agency Transfer"), whereby, among other things, Barclays resigned as Administrative Agent and JPM was appointed as successor Administrative Agent; and

WHEREAS, the Resigning Administrative Agent and the Successor Administrative Agent have agreed to execute this Notice of Assignment and Assumption of Security Interest in Intellectual Property (this "Notice") to evidence the transfer and assignment of the Resigning Administrative Agent's security

interest in the IP Collateral for recordation with the United States Patent and Trademark Office, the United States Copyright Office, the Canadian Intellectual Property Office and the Canadian Industrial Design Office.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Resigning Administrative Agent and the Successor Administrative Agent hereby agree as follows:

1. Effective Date. The effective date of this Notice shall be February 20, 2024 (the “Effective Date”).

2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Agency Transfer, as of the Effective Date, among other things, (a) the Resigning Administrative Agent was discharged from its duties and obligations as Administrative Agent under the Intellectual Property Security Agreements, and (ii) transferred and assigned to the Successor Administrative Agent each of the security interests in the IP Collateral granted to the Resigning Administrative Agent under the Intellectual Property Security Agreements (the “Assigned Liens”), and (b) the Successor Administrative Agent (i) succeeded to the rights and obligations of the Resigning Administrative Agent, and became vested with all of the rights, powers, privileges and duties of the Resigning Administrative Agent under the Intellectual Property Security Agreements, in each case, other than as expressly set forth in the Agency Transfer, and (ii) assumed all the Assigned Liens for its benefit and for the benefit of the other secured parties.

3. Continuity of Security Interest. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the IP Collateral originally granted to the Resigning Administrative Agent under the Intellectual Property Security Agreements.

4. Reference to Administrative Agent. From and after the Effective Date, each reference in the Intellectual Property Security Agreements to “Administrative Agent” shall be deemed to be a reference to JPM, in its capacity as Successor Administrative Agent.

5. Governing Law. THIS NOTICE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.






