RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 21st day of February, 2024 by CIT NORTHBRIDGE CREDIT LLC, as Agent (“Agent”), in favor of MOHAWK FINE PAPERS INC., a New York corporation and CRANE STATIONERY, LLC, a Massachusetts limited liability (each, a “Company” and collectively, the “Companies”).

WHEREAS, in connection with the Loan, Security and Guarantee Agreement, dated August 4, 2022 (including all exhibits and schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified, the “Loan Agreement”), by and among Companies, each of the other Persons from time to time party thereto as “Borrowers” (“Borrowers”), each of the other Persons from time to time party thereto as “Guarantors” (“Guarantors”), Agent, and the financial institutions from time to time party thereto (“Lenders”), Agent and Lenders agreed to make Loans for the benefit of the Borrowers;

WHEREAS, the Loan Agreement required the Companies to execute and deliver that certain Trademark Security Agreement, dated as of August 4, 2022 (the “Trademark Security Agreement”), pursuant to which each Company, as collateral security for the prompt payment and performance of the Obligations, granted to Agent, on behalf of itself and the Lenders, a first priority security interest in all of its right, title and interest in, to and under the following (collectively, the “Trademark Collateral”):

- (a) all of its registered Trademarks set forth on Schedule A hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) subject to the Loan Agreement, all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(d) subject to the Loan Agreement, all proceeds of the foregoing, including, without limitation, any claim by Company against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 4, 2022 at Reel/Frame 7812/0439 and a supplement to the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 26, 2023 at Reel/Frame 8109/0629; and

WHEREAS, Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral, and to reconvey any and all rights in the Trademark Collateral to the Companies.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent, on behalf of itself and the Lenders, hereby terminates, releases and discharges all liens and security interests granted by Companies in favor of Agent in the Trademark Collateral, and hereby re-assigns to the Companies any and all right, title or interest it or any Lender may have in, to or under such Trademark Collateral, and any right, title or interest of Agent or any Lender in such Trademark Collateral shall hereby cease and become void.

Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby. Agent hereby authorizes each Company or Company's authorized representatives to record this Release of Security Interest in Trademarks with the United States Patent and Trademark Office and/or any other applicable governmental office or agency to memorialize the release of the security interest of Agent in the Trademark Collateral.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan Agreement.
