**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of March 1, 2024, and made by **CITIBANK, N.A.**, a national banking association (the "Grantee"), to **ADORAMA INC.**, a New York corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 28, 2023 (the "Security Agreement"), made by Grantor in favor of Grantee, a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on March 1, 2023 at Reel/Frame 7988/0153;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Termination and Release of Security Interest. Grantee hereby fully and finally releases and terminates the Security Agreement and terminates, releases and discharges any and all liens and security interests in any and all right, title and interest in, to and under the (i) Intellectual Property; (ii) all proceeds and products of the Intellectual Property; (iii) all goodwill associated with the Intellectual Property; and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Intellectual Property; and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.

3. This Termination constitutes a complete termination and release by Grantee of its security interest, and all other right, title and interest the Grantee may have in any Intellectual Property under the Security Agreement.

4. The Grantee hereby authorizes Grantor or Grantor's agent to record this Termination with the United States Patent and Trademark Office.

5. This Termination may be executed electronically, and each signature will for all purposes have the same validity, legal effect, and admissibility in evidence as an original manual signature.
