TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Termination and Release”) dated as of March 1, 2024, made by JPMorgan Chase Bank, N.A., as administrative agent for the Lenders (together with any successors and permitted assigns thereto, in such capacity, the “Administrative Agent”), is in favor of Eqlipse Technologies, LLC, a Maryland limited liability company, SR Technologies, Inc., a Florida corporation and SRT Wireless, LLC, a Florida limited liability company (each, a “Grantor”). All capitalized terms used by not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WHEREAS, each Grantor and the Administrative Agent entered into that certain (i) Pledge and Security Agreement, dated as of November 21, 2023 (the “Security Agreement”), by and among, each Grantor, the other parties party thereto and the Administrative Agent and (ii) Confirmatory Grant of Security Interest in United States Trademarks, dated as of November 21, 2023 (as amended, modified or supplemented prior to the date hereof, the “Trademark Agreement” and together with the Security Agreement, the “Security Documents”), granting Administrative Agent security interests in and liens on certain trademarks described therein (the “Trademark Collateral”);

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on November 21, 2023 at Reel 8264, Frame 0725; and

WHEREAS, the Administrative Agent now desires to terminate the Security Documents and terminate, release and discharge its security interest in all Trademark Collateral including the United States registered trademarks and trademark applications set forth in Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:


1. terminates the Security Documents and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges all pledges, grants, liens and security interests in each Grantor’s right, title and interest in, to and under the Trademark Collateral under the Trademark Agreement, including the Trademark Collateral identified in Schedule A hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. understands and agrees that this Termination and Release may be recorded by or for each Grantor, or such successors or assigns with the USPTO.
