## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby releases all liens and security interests granted by Grantor in favor of Administrative Agent in the following (collectively, the "Trademark Collateral"): (a) the trademarks listed on Schedule A attached hereto (each, a "Trademark") pursuant to that certain Security Agreement, dated as of December 17, 2021, executed by Grantor in favor of Administrative Agent, and that certain Trademark Security Agreement, dated as of December 17, 2021, executed by Grantor in favor of Administrative Agent and recorded with the United States Patent and Trademark Office on December 17, 2021 at Reel/Frame 7533/0761, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use or, or symbolized by, each Trademark and (b) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to the goodwill associated with any Trademark. Administrative Agent hereby reassigns, grants and conveys to the Grantor, any and all of Administrative Agent's right, title and interest in and to the Trademark Collateral. Grantor (and any person or entity hereafter holding any right, title or interest in the Trademark Collateral of Grantor) is hereby authorized to record this Release with respect to the Trademark Collateral of Grantor.
