**“ARTICLE I**

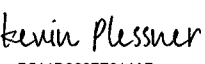

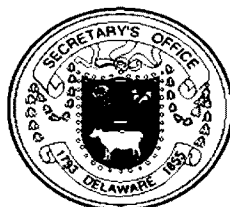

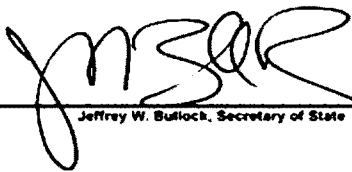
