TRADEMARK ASSIGNMENT

WHEREAS, Assignor and Assignee desire for Assignor to confirm of record Assignor’s assignment, transfer, and conveyance of such Trademark Rights, and for Assignee to acknowledge and accept the same as memorialized in this Trademark Assignment.

NOW, THEREFORE, in consideration for payment of \$10 by Assignee to Assignor, and for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereto agree as follows:

Assignor hereby confirms that it has transferred, assigned, and conveyed to Assignee, subject to the IP Encumbrances (as defined below), as of the Effective Date, the following “**Trademark Rights**”: all of Assignor’s right, title, and interest in and to the trademark application listed in Exhibit A, the “**Assigned Trademark**”, which is attached hereto and incorporated herein by reference, together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademark, and the right to sue for, and obtain remedies in connection with, past, present, and future infringement of the Assigned Trademark, including the right to obtain an injunction, royalties, or any other damages, other than Excluded Ancillary IP Rights (defined below), and Assignee hereby acknowledges and accepts the same.

For the purposes of this Trademark Assignment, “**Excluded Ancillary IP Rights**” means any and all of the rights of NCR Voyix or any of its affiliates as described in the Confirmatory Trademarks Rights Assignment between the Assignor and NCR Voyix Corporation.

This Trademark Assignment is binding upon, and inures to the benefit of Assignor and Assignee and their respective affiliates, successors and assigns.

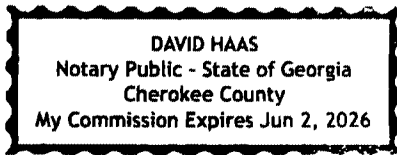

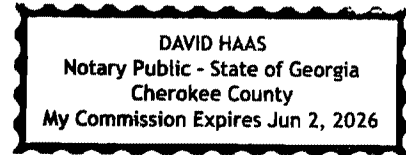
