NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:


Assignor hereby irrevocably conveys, transfers, and assigns to Assignee all of Assignor’s right, title, and interest, in and to:

- (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to, and claims for, damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
