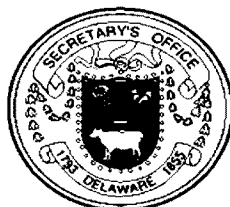

SECOND: The date the Certificate of Incorporation of the Converting Corporation was originally filed with the Secretary of State of the State of Delaware was May 5, 2015.


THIRD: The name of the limited liability company as set forth in the Certificate of Formation is Quadro Partners, LLC (the “**Company**”).
