TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of March 7, 2024, by ICG DEBT ADMINISTRATION, LLC, a Delaware limited liability company (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of LEVERPOINT MANAGEMENT, LLC, a Delaware limited liability company with an address at 5 Maxwell Drive, Suite 135, Clifton Park, New York 12065 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 12, 2019 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on April 8, 2020 at the United States Patent and Trademark Office at Reel 6911, Frame 0250.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
