RELEASE OF SECURITY INTERESTS IN TRADEMARKS

Secured Party hereby authorizes Debtor to file directly with the United States Patent and Trademark Office this Release and any ancillary documentation as may be reasonably necessary in order to effect the release of Secured Party's security interests in the Debtor Intellectual Property as contemplated hereby.
