## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of September 29, 2017, is from Exact Holding North America, Inc., a Delaware corporation ("Assignor"), in favor of Exact Group, B.V., a private company with limited liability (*besloten vennootschap met beperkte aansprakelijkheid*) incorporated under the Laws of the Netherlands, having its seat (*statutaire zetel*) in Delft, the Netherlands and its business address at Molengraaffsingel 33, 2629 JD Delft, the Netherlands, registered with the Trade Register of the Dutch Chamber of Commerce under file number 27225828 ("Assignee"). Capitalized terms used herein and not otherwise defined herein shall have the meanings set forth for such terms in the EIPA (as defined below).

WHEREAS, Assignee and Eclipse Topco Holdings, L.P., a Delaware limited partnership ("Purchaser"), have entered into that certain Equity Interest Purchase Agreement, dated as of July 27, 2017 (the "EIPA"), pursuant to which, among other things, Seller is selling and transferring or causing to be sold and transferred to Purchaser the Equity Interests, all as more fully set forth in the EIPA; and

WHEREAS, pursuant to the EIPA, among other things, Assignee agreed to cause Assignor to sell, transfer, assign and deliver to Assignee all right, title and interest in and to the registered trademark, set forth in Schedule A ("Assigned Mark") hereto.

NOW, THEREFORE, the parties agree as follows:

1. Assignment. As of the date hereof, Assignor hereby irrevocably sells, assigns, transfers and delivers to Assignee, and Assignee hereby purchases, acquires and accepts from Assignor, all right, title and interest in and to the Assigned Mark worldwide, together with the goodwill of the business connected with use of, and symbolized by, the Assigned Mark, including, but not limited to, any applications or registrations therefor, together with all income, royalties, damages and payments due or payable as of the date hereof or thereafter, including damages and payments for past, present and future infringements, misappropriations or other violations thereof, the right to sue and recover for past, present and future infringements, misappropriations and other violations thereof and any and all corresponding rights or interests that, now or hereafter, may be secured throughout the world.
2. Recordation. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office, and the officials of corresponding entities or agencies in any applicable jurisdictions worldwide to record and register this Assignment upon request by Assignee.
3. Further Assurances. From time to time following the date hereof, Assignor shall, at Assignee's reasonable request and expense, execute and deliver such documents and other papers and perform any other actions as may be required to carry into effect and perfect the assignments and transfers in this Assignment or to enable Assignee to obtain the full benefits of this Assignment.
4. Successors and Assigns; No Third Party Beneficiaries. This Assignment shall be

binding upon and inure to the benefit of the parties and their respective successors and legal representatives. Nothing herein expressed or implied is intended or shall be construed to confer upon or give to any person or entity any rights or remedies under or by reason of this Assignment nor be relied upon other than the parties hereto and their permitted successors or assigns.

5. Counterparts. This Assignment may be executed in one or more counterparts, all of which together shall constitute a single document. Counterparts of this Assignment (or applicable signature pages hereof) that are manually signed and delivered by facsimile transmission or PDF file shall be deemed to constitute signed original counterparts hereof and shall bind the parties signing and delivering in such manner.

6. GOVERNING LAW. THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE, WITHOUT REGARD FOR THE CONFLICTS OF LAW PRINCIPLES THEREOF THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER STATE.


