**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE (this “Release”) is made as of March 8, 2024, by Twin Brook Capital Partners, LLC, in its capacity as agent for all Lenders (in such capacity, “Agent”), in favor of Fiesta Insurance Franchise Corporation, a Delaware corporation (“Grantor”), pursuant to the Guarantee and Collateral Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Guarantee and Collateral Agreement.

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement dated as of October 19, 2018 (as amended and restated by that certain Amended and Restated Guarantee and Collateral Agreement, dated as of February 1, 2021 and as further amended, restated, supplemented or otherwise modified from time to time the “Guarantee and Collateral Agreement”), by and among Grantor, the other grantors party thereto and Agent, Grantor pledged and granted to Agent, for the ratable benefit of the Lenders, a security interest in all of Grantor’s Collateral;

WHEREAS, Grantor and Agent were parties to that certain Trademark Security Agreement, dated as of October 19, 2018 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), pursuant to which Grantor granted to Agent, for the ratable benefit of the Lenders, a security interest (the “Security Interest”) in the Trademark Collateral (as defined below) to secure the payment and performance of the Secured Obligations;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on October 19, 2018 at Reel 6468, Frame 0160; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to the terms and conditions of the Guarantee and Collateral Agreement, Agent hereby states as follows:

1. Agent hereby terminates the Trademark Security Agreement and terminates, releases, and discharges its Security Interest, and all of its right, title and interest in, to and under the following (collectively the “Trademark Collateral”) shall hereby cease and become void:

a. each Trademark listed on Schedule A annexed hereto, together with any renewals or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the Goodwill associated with each such Trademark.

2. Agent hereby agrees, at Grantor’s expense, to execute and deliver to Grantor such documents, instruments, notices and releases as Grantor shall reasonably request to evidence the release of the Security Interest contemplated hereby.


3. THIS AGREEMENT SHALL BE A CONTRACT MADE UNDER AND GOVERNED BY THE INTERNAL LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS

MADE AND TO BE PERFORMED ENTIRELY WITHIN SUCH STATE, WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANY STATE OTHER THAN THE STATE OF NEW YORK.
