The undersigned, pursuant to the provisions of Section 14-2-1109.3 of the Georgia Business Corporations Code (the "Code"), and on behalf of Noble Systems Corporation, a Georgia corporation (the "Corporation"), hereby adopts and files this Certificate of Conversion for the purpose of converting the Corporation into Noble Systems, LLC, a Delaware limited liability company (the "LLC"):
