RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

March 1, 2024

WHEREAS, Velosio, LLC, a Delaware limited liability company (the "**Grantor**") granted a security interest in, and lien upon, all of Grantor's right, title and interest in, to and under any and all of the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement referred to below) to Brightwood Loan Services LLC, in its capacity as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, "**Agent**") for the Secured Parties (as defined in the Credit Agreement referred to in the Security Agreement (defined below)) as set forth in (a) the Intellectual Property Security Agreement, dated as of February 22, 2019 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "**Intellectual Property Security Agreement**"), made by the Grantor in favor of the Agent, and (b) the Security Agreement, dated as of February 22, 2019 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "**Security Agreement**" and, together with the Intellectual Property Security Agreement, the "**Security Agreements**"), by and among the Grantor, the other grantors from time to time party thereto and the Agent;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on March 5, 2019 at Reel/Frame 006582/0627;

WHEREAS, Grantor has requested that the Agent release and reassign its security interest in the Intellectual Property Collateral, including the registered trademarks more fully identified in Schedule I annexed hereto and made a part hereof (including, without limitation, all goodwill associated therewith) (the "**Released Trademarks**");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:


1. Without recourse or representation or warranty, express or implied, of any kind or nature whatsoever to the Agent or any other Secured Party, (a) the Agent hereby releases, relinquishes and discharges any and all liens and security interests in and to all of Grantor's right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, the Released Trademarks, and (b) reassigns, regrants and reconveys to Grantor any and all of Agent's right, title and interests (if any) in, to and under the Intellectual Property Collateral, including, without limitation, the Released Trademarks, in each case granted pursuant to the Security Agreements.


2. The Agent hereby (a) agrees that the Intellectual Property Security Agreement is, without further action, automatically terminated and of no further force or effect, (b) authorizes Grantor or its authorized representatives to record this Release of Security Interest in Intellectual Property Collateral (the "**Release**") with the U.S. Patent and Trademark Office and (c) authorizes and requests that the U.S. Patent and Trademark Office note and record the existence of this Release hereby given, at Grantor's sole cost and expense.
