

The names and states of incorporation of the merging corporations are Imagine That, Inc., a California corporation, the merged corporation, and ANDRITZ Inc., a Georgia corporation, the surviving corporation. Imagine That, Inc. is a wholly-owned subsidiary of ANDRITZ Inc.

The merger shall become effective at 12:01 a.m., January 1, 2024.




