**Release of First Lien Trademark Security Interest**

This Release of First Lien Trademark Security Interest, dated as of March 13, 2024 (the “Release”), is made by GOLDMAN SACHS BANK USA, as Collateral Agent for the Secured Parties (in such capacity, the “Agent”) in favor of TENEIO HOLDINGS LLC, a Delaware Limited Liability Company (the “Grantor”).

WHEREAS, by (i) that certain First Lien Security Agreement, dated as of July 12, 2019, by and among the Grantor, the other grantors party thereto and the Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related First Lien Trademark Security Agreement, dated as of July 12, 2019, in favor of Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 18, 2019 at Reel 6696, Frame 0911, Grantor granted to Agent, for the benefit of the Secured Parties, a security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those trademarks listed on Schedule I hereto;

WHEREAS, Grantor desires Agent to release, discharge, terminate and cancel its security interest in the Trademark Collateral, including, without limitation, the trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademark Collateral and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Trademark Collateral.

The Agent authorizes and requests that the Commissioner for Trademarks, and any other applicable government officer, record this Release.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
