Pursuant to Section 1003 of the Limited Liability Company Law of the State of New York, the undersigned hereby certify as to the following facts relating to the merger (the "Merger") of Rear View Safety Inc., a New York corporation (the "Merged Corporation"), with and into Rear View Safety Newco LLC, a New York limited liability company (the "Surviving Entity"):

FIRST: The name and jurisdiction of incorporation of the Merged Corporation are Rear View Safety Inc., a New York corporation, and its Certificate of Incorporation was filed with the Department of State of the State of New York on September 11, 2007.


