Pursuant to Section 907 of the New York Business Corporation Law (the "NYBCL"), each of the undersigned hereby certify on behalf of the constituent corporations named herein, as follows:

1. The name of each constituent corporation is as follows:

(a) (Merging Corporation) Lovebug Nutrition Inc, a New York corporation. The name under which it was originally formed is "Lovebug Nutrition Inc".

(b) Surviving Corporation is... Lovebug Nutrition, Inc., a Delaware corporation.

2. The name of the surviving corporation is Lovebug Nutrition, Inc, a Delaware corporation (the "Surviving Corporation").

4. The original certificate of incorporation of Lovebug Nutrition Inc (MERGING CORPORATION) was filed by the New York State Department of State (the "Department of State") on October 3, 2014. A restated certificate was filed on October 25, 2017.

5.

(a) Lovebug Nutrition, Inc. (SURVIVING CORPORATION) was incorporated in Delaware on February 2, 2018.

(b) No application for authority for Lovebug Nutrition, Inc. the surviving corporation to do business in the State of New York has been filed with the Department of State. Lovebug Nutrition, Inc. The surviving corporation shall not do business in the State of New York until an application to do business has been filed with the Department of State.

6. The merger was authorized with respect to Lovebug Nutrition Inc. [MERGING CORPORATION] in the following manner: A plan of merger was adopted by the board of directors of Lovebug Nutrition Inc. [MERGING CORPORATION] by written consent on February 10, 2018, by the unanimous vote of the board of directors. The board submitted the agreement of merger to a vote of shareholders. The agreement was adopted by written consent of the shareholders by vote of the holders of a majority of all outstanding shares entitled to vote thereon.

7. Lovebug Nutrition, Inc, the (SURVIVING CORPORATION)] has complied with the provisions of the laws of its jurisdiction of incorporation applicable to this merger and this merger is permitted by such laws. The manner in which the merger was authorized with respect to Lovebug Nutrition, Inc.(SURVIVING CORPORATION) was as follows: A plan of merger was adopted by the board of directors of Lovebug Nutrition, Inc. The Surviving Corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of any New York or foreign corporation, previously amenable to suit in New York, which is a constituent corporation in this merger, and for the enforcement, as provided in the NYBCL, of the right of shareholders of any constituent New York corporation to receive payment for their shares against the Surviving Corporation. The Surviving Corporation irrevocably appoints the Secretary of State of the State of New York (the "Secretary of State") as its agent to accept service of process in any action or special proceeding. (MERGING CORPORATION)] the amount, if any, to which they shall be entitled under the provisions of the NYBCL, relating to the rights of shareholders to receive payment for their shares.
