EXHIBIT C

ASSIGNMENT OF TRADEMARK

This Assignment agreement entered this 22nd day of February 2024, between Home Depot Product Authority, LLC, a Georgia limited liability company with a principal business address of 2455 Paces Ferry Road NE, Atlanta, Georgia 30339 (hereinafter “Assignee” or “HD”) and Jupiter Industries Limited, a Limited Company of the United Kingdom, 37 Station Road, Lutterworth, Leicestershire, United Kingdom LE17 4AP (hereinafter “Assignor” or “Jupiter”).

WHEREAS Assignor is the owner of the trademark HUSKY for use in connection with refrigerating appliances, refrigerating cabinets, portable refrigerated boxes and refrigerating cabinets, household and commercial refrigerators, beverage coolers, and refrigerated display cabinets, and for which it owns U.S. Federal Trademark Registration No. 4,900,705 for the mark HUSKY (hereinafter, the “HUSKY Mark”);

WHEREAS U.S. Registration No. 4,900,705 covers the following goods in International Class 11:

Refrigerating apparatus, installations and appliances, and freezing apparatus, installations and appliances, namely, freezers, freezing showcases and ice machines, refrigerating cabinets, refrigerating chambers; refrigerating containers in the nature of refrigerator shelving, drawers, bins and trays, portable refrigerated rooms, portable refrigerated boxes and refrigerating cabinets; household and commercial refrigerators; cooling apparatus and instruments, namely, beverage-cooling apparatus, cooling domes, cooling evaporators, cooling installations for water, cooling units for industrial purposes, portable thermoelectric cooling units for food and beverages; cold rooms, namely, portable refrigerated rooms, walk-in coolers, walk-in refrigerators, walk-in freezers; refrigerated display cabinets; freezers; thermo-electric coolers for food and beverages; ice makers; structural parts and fittings for all the aforesaid goods;

WHEREAS Assignor desires to assign all its right, title and interest it now has or ever had in the HUSKY Mark for household refrigerators or related consumer goods (the “HD Goods”) in the United States and its territories and possessions to Assignee; and

WHEREAS Assignor desires to retain its rights in the HUSKY Mark for commercial refrigerators and freezers to be sold to commercial customers for use in bars, food stores and restaurants (the “Jupiter Goods”);

NOW THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby assigns unto Assignee, all its right, title and interest in and to U.S. Reg. No. 4,900,705 in connection with the HD Goods in the United States and its territories and possessions, together with the goodwill of the business symbolized by the HUSKY Mark in

connection with the HD Goods and any and all common law rights to the HUSKY Mark in connection with the HD Goods, including but not limited to Class 11 “household refrigerators” specified in U.S. Registration No. 4,900,705, with each and all registered and common law rights together with all right, title and interest therein.

The Assigned rights include the priority of use for the HUSKY Mark in connection with the HD Goods and the right (but not the obligation) to assert the HUSKY Mark and any other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto by reason of any past and future acts of infringement of the HUSKY Mark in connection with HD Goods that have occurred or may occur.

For the avoidance of doubt, Assignor retains its right, title and interest in and to U.S. Reg. 4,900,705 and the HUSKY Mark in connection with the Jupiter Goods.

Consistent with the assignment made herein, Assignor and Assignee hereby agree that U.S. Registration 4,900,705 shall be divided as set forth herein in accordance with TMEP § 501.06, and each agrees to take such further and other steps and to promptly execute such further and other documents and amendments to give full force and effect to the assignment granted herein.
