Reference is made to the Loan and Security Agreement, dated as of November 21, 2018, and Side Letter (RE: Fee In Lieu of Warrant), dated January 3, 2019 (the "Closing Date"), and Second Loan and Security Modification Agreement, dated September 30, 2019, and Third Loan and Security Modification Agreement, dated January 3, 2020, and Fourth Loan and Security Modification Agreement, dated January 27, 2020, as may be amended, restated, supplemented, otherwise modified (the "Loan and Security Agreement") by and between Western Alliance Bank, an Arizona corporation ("Bank") and Cloudbreak Health, LLC, a Delaware limited liability company, Language Access Network, LLC, a Delaware limited liability company, and Carenection, LLC, a Delaware limited liability company (each a "Borrower" and, collectively, "Borrowers"). Capitalized terms used but not otherwise defined herein shall have the meanings given them in the Loan Agreement.

Borrower has advised Bank that it intends to repay all amounts due and owing under the Loan Agreement and the other Loan Documents and has requested that Bank provide Borrower with pay-off amounts for the obligations owing by Borrower to Bank under the Loan Documents. The foregoing accrued interest amount assumes no change in the operative interest rates after the date hereof. The foregoing principal balance assumes no additional Credit Extensions under the Loan Agreement and this letter agreement confirms that Borrower has waived the right to seek any such additional Credit Extensions, and Bank shall not make, any further Credit Extensions under the Loan Documents to or for the benefit of Borrower.
