RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of March 15, 2024, (this “*Release*”) is made by **WOODFOREST NATIONAL BANK**, as Administrative Agent for the Secured Parties (in such capacity, the “*Administrative Agent*”) under the Intellectual Property Security Agreement dated as of November 12, 2020 (the “*Intellectual Property Security Agreement*”), between **SSPI HOLDINGS, INC.**, a Delaware corporation, **STRUCTURAL AND STEEL PRODUCTS, INC.**, a Texas corporation, **STRUCTURAL AND STEEL MANAGEMENT, LLC**, a Texas limited liability company, and **STRUCTURAL AND STEEL PRODUCTS MANUFACTURING, LTD.**, a Texas limited partnership (each a “*Grantor*” and collectively the “*Grantors*”) and the Administrative Agent. Capitalized terms used but not defined herein have the meanings provided in the Intellectual Property Security Agreement.

WHEREAS, pursuant to the Intellectual Property Security Agreement which was recorded at the United States Patent and Trademark Office on November 17, 2020, at Reel 7108 and Frame 0908, the Grantors granted to the Administrative Agent a continuing security interest in all of the Grantors’ right, title and interest in Intellectual Property, including those set forth on the attached Schedule 1.


WHEREAS, the Grantors have requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral (the “*Released Collateral*”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Intellectual Property Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantors any and all right, title and interest it has in the Released Collateral.
